In the event of an actual emergency, the Northern Florida Emergency Net will meet on this frequency, 3950 KHz, and will handle only emergency related Traffic in accordance with the Northern Florida Section Emergency Communications Plan.

The Northern Florida Phone Net meets daily at 1930 Eastern, 1830 Central, on or about 3950 KHz. This is a directed net - please follow the instructions of the Net Control Station. If you would like to be added to the roll call, please send a Radiogram or Email to the assistant net manager, Dave, AI4GF and your name will be added to all Net Control rosters. Stations in the South Florida Section, West Central Florida Section, and our neighboring states of Alabama, Georgia and several other states may check in at the end of the roll call when I call for those areas.
